Please note: So that the office staff can spend their time preparing for the show on Wednesday, we ask that **ALL EXHIBITORS** send in **all of the requested information along with the proper amount of funds**. If everything is complete and paid for, your show packet will be in a box outside of the office and you may pick it up at your convenience. If you did not include all of the requested information or did not include the proper amount of funds, or there are signatures missing, expired membership cards, etc. we will be holding your show packet in the office and you will be assessed a \$10 charge which must be paid before you will be issued your packet. To assist you in making sure you have included everything we need, we have provided below a 7 step check list.

Registration Reminders

A fee of \$10 will be charged for every incomplete or incorrect entry blank. Be sure:

- 1. All required information is filled out (INCLUDING ZIP CODES !).**
- 2. Copies of Registration Papers are included.**
- 3. Copies of membership cards are included.**
- 4. Membership cards are current (you will be charged \$20 if your card is *EXPIRED*).**
- 5. Required signatures are in place.**
- 6. Copy of 2008 Negative coggins test is included.**
- 7. Fees are correct.**

Entries Close June 12, 2008

If stabling is available, late entries will be accepted at an extra fee of \$5.00 per class.

If a horse has more than one rider, copy the form and enter the second exhibitor on the additional form.

Stabling will be available at Noon, Wednesday, June 25, 2008

Stall Fees: **MHSA Member Stalls - \$45**
 Non- MHSA Member Stalls - \$50
 Shown from trailer, per horse - \$25

We reserve the right to limit or eliminate tack stalls as necessary.

Stable - with requests: Exhibitors wishing to be stabled together must all use the **same name**. In other words, if Smith and Jones want to be stabled together they must both indicate **Stable with Smith**. If one says Smith and the other says Jones, they will NOT be stabled together.

Stabling Office Hours: Wednesday - Noon to 10:00 p.m. Thursday & Friday, 9:00 a.m. to 5:00 p.m. A stall chart will be posted at the stabling office for late arrivals. **Anyone occupying a stall not assigned to them will be subject to dismissal and forfeiture of all fees.**
